The Parish Council object to this application on the following grounds:- -The proposed outline application is contrary to Policy BO-D1 of Barby & Onley Neighbourhood Plan as it would alter the street scene in relation to green space “Lees Pit” identified in the plan. -The access onto Kilsby Road is of concern, as it is adjacent to a Sycamore tree protected by virtue of a Tree preservation order TPO 10/T6 and also a telegraph pole. Access to the proposed site is opposite Barby Play Area which is used for play and leisure equipment and for Parish events and is a significant asset to the village. The play area is accessed by a large number of children and access off Kilsby road would compromise their safety. -The proposed development is in front of the building line for Kilsby road, and situated very close to the boundary wall with the adjacent property which may damage the wall.
